Pursuant to Law on Enterprise No.59/2020/QH14 dated 17/06/2020; Pursuant to the Charter of Vietnam Container Shipping Joint Stock Corporation; Pursuant to the Company's business plan;

The Board of Directors of Vietnam Container Joint Stock Company (VSC) respectfully submits to the General Meeting of Shareholders ("AGM") for consideration and approval:

Pursuant to AGMS Resolution No. 04/2022/NQ-DHĐCD dated January 17, 2023 on collecting shareholders' written opinions for the second time in 2022 on approving the policy of implementing the investment program to receive transfer achieving a controlling ratio at an enterprise in the seaport sector and a policy of mobilizing capital to implement the investment program. VSC has been implementing the above investment program in accordance with the AGMS Resolutions and approval from competent state agencies. Now we would like to submit to the AGMS for consideration and approval of receiving the transfer of the investment program from controlling ownership to own 100% of the charter capital of the Target Company, specifically as follows:

1. Approving transactions of receiving capital transfer from existing capital contributing members of Nam Hai Dinh Vu Port Co., Ltd. with the aim of increasing the ownership ratio to a maximum of 100% of charter capital of Nam Hai Dinh Vu Port Co., Ltd in case the transaction has the value of over 35% of the total value of VSC's assets recorded in the most recent financial report on the basis of ensuring the Company's interests.

2. Assign the Board of Directors ("BOD") on the basis of authority, ensuring the rights and interests of VSC, to carry out the following contents:

- Negotiate with capital contributing members of Nam Hai Dinh Vu Port Co., Ltd. to receive the transfer of capital contributions at Nam Hai Dinh Vu Port Co., Ltd. with the aim of increasing the ownership ratio to the maximum level of ownership 100% charter capital of Nam Hai Dinh Vu Port Co., Ltd.

- Decide on the transfer price to own up to 100% of the charter capital of Nam Hai Dinh Vu Port Co., Ltd.

- Negotiate and approve the content of the contract to receive capital transfer from capital contributing members of Nam Hai Dinh Vu Port Co., Ltd.

In the process of implementing the above contents, the Board of Directors has the right to: (i) Decide on contents within the scope of assigned/authorized tasks; (ii) perform and/or direct and assign tasks to units and individuals at VSC: Carry out necessary work according to regulations; Complete and sign relevant documents; Carry out necessary work and procedures to carry out assigned and authorized tasks, in accordance with legal regulations.
